The Iconic Week Celebrations will be inaugurated by the Hon'ble Prime Minister of India, in the presence of Hon'ble Finance Minister at **10:00 AM on 06.06.2022 (Monday)** at Vigyan Bhawan, New Delhi. The following functions will be telecast live across 75 cities from Vigyan Bhavan:

- a. Inauguration of *Digital Exhibition* by Hon'ble PM.
- b. Video '*Rupaya Ka Rochak Safar*' in Hindi.
- c. *Launch of circulation coins with AKAM design* by Hon'ble PM.
