CIRCULAR

It is observed that divergent practices are being followed by different Commissionerates falling under Hyderabad/Vizag zones for allowing candidates to appear for departmental examinations for promotion to the post of Tax Assistant/Executive Assistant (STA)/Inspectors. It is understood that some Commissionerates allowed candidates to appear for the said examination even before completion of the normal probation period of two years of regular service where as other Commissionerates are insisting for completion of two year's regular service. The above disparity had led to generation of multiple litigations which are avoidable had uniform practice was followed by the respective Commissionerates.

2. The issue has been re-examined. In the light of Board's circular dated 16.06.2008 read with F.No.A.32018/24/2016-AdIIIA dated 23.06.2016 read with F.No.VI/Estt /36/01/2016-NACEN dated 28.06.2016, wherein it was clarified that eligible feeder cadre officers with two years of regular service alone are allowed for appearing in the Departmental Examination for the post of Tax Assistant.


3. In view of the above, henceforth candidates who have completed two years of regular service in the feeder cadre namely LDCs may be permitted to take departmental examination to the cadre of Tax Assistant.

4. Similarly, candidates who have completed two years of service in the feeder cadre namely Tax Assistant may be permitted to take the Departmental Examination for promotion to the cadre of Executive Assistant(STA)/Inspector.

5. All the Commissionerates of Hyderabad and Vizag Zones are requested to strictly follow the above norm to avoid litigation in this regard.

6. The Provisional permission allowed vide C.No.II/12/01/2014-Esst.CC (HZ) 485 dated 18.06.2015 stands rescinded.

7. This issues with approval of Chief Commissioner.
